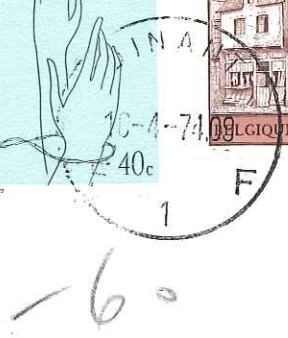
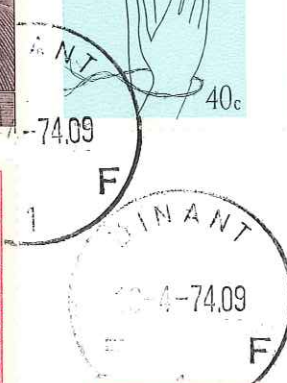

Underpaid Letter: Air Mail Surtax



Bandoeng (Bandung), Java, Netherlands West Indies (Dutch colony),
to Zurich, July 20 to 27, 1937.

Paid: 15 cents/20gr + 10c/5gr x 2 air mail surtax for 9gr (pencil notation) = 35¢.

Prepaid rate: letter apparently weighed again and **charged 10c more**
air mail surtax for more than 10gr.

Deficiency: 10¢ Dutch = $16\frac{2}{3}$ c gold = 20c Swiss.

Origin tax mark: $33\frac{1}{3}$ c = double deficiency in gold centimes.

Postage due: 2 x 20c Swiss = 40c.

Forwarded to Baden for collection of postage due
after it was annulled (*ungültig*) in Zurich.

Postage due stamps from 1924 and 1937 (overprinted) issues.
