 The Great Smoky Mountain area, consisting of 466,577 acres in North Carolina and Tennessee, was established as a National Park area in 1930 for development at some future time when further donations of land should increase its area to a prescribed minimum. The lands are under Federal protection. It is a vast, unspoiled region of incomparable beauty. Virgin forests, towering mountains, curious rock formations and far-flung vistas of valleys and gorges with many crystal cascades are a few of the many outstanding features of this last great wilderness of the East.
