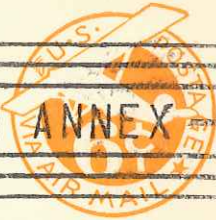

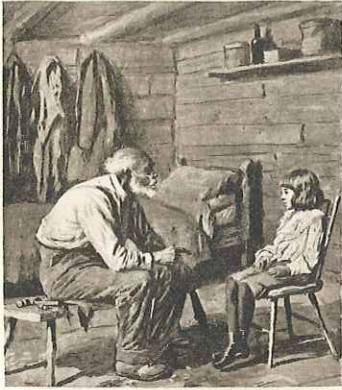

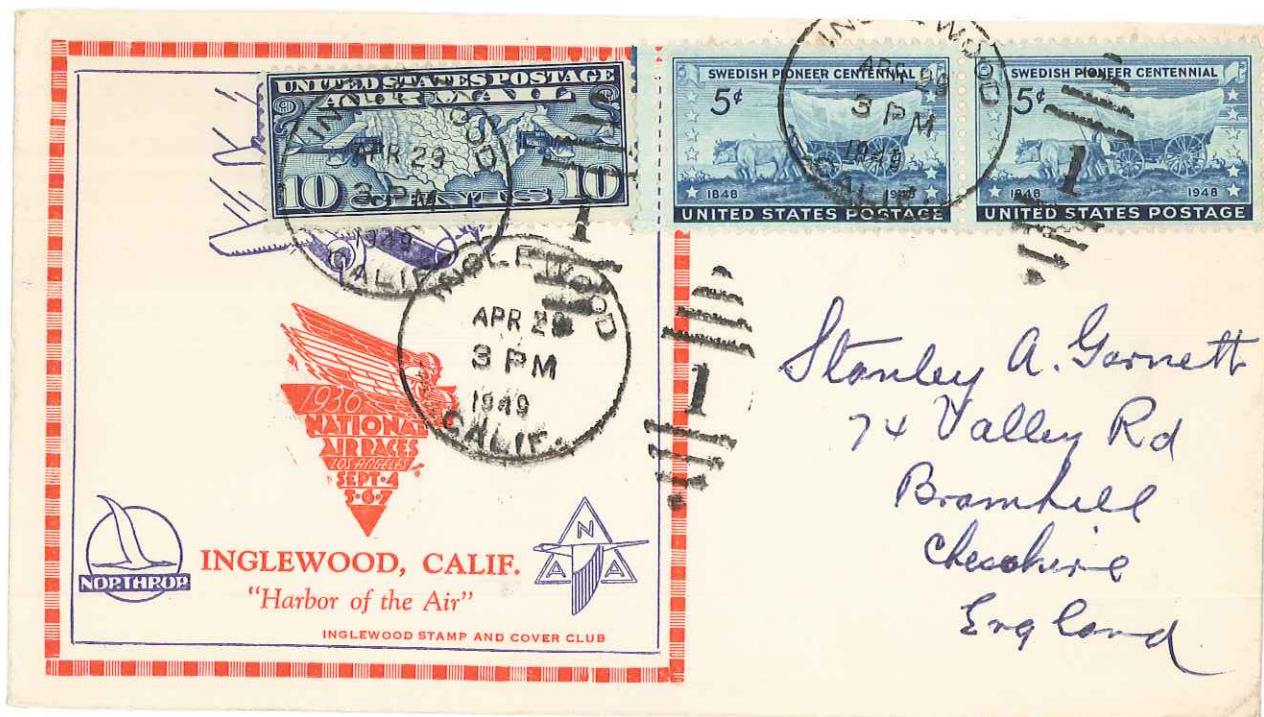

JOEL CHANDLER HARRIS, JOURNALIST AND AUTHOR, WAS BORN AT EATONTON, GA., DEC. 8, 1848. HE BEGAN AS A PRINTER'S APPRENTICE; LATER, WAS ON THE STAFF OF SAVANNAH "DAILY NEWS." FOR 25 YEARS HE WAS A WRITER FOR ATLANTA "CONSTITUTION." HE IS BEST KNOWN FOR HIS CHILDREN'S STORIES BASED ON HIS OBSERVATION OF PLANTATION NEGROES AND TOLD THRU HIS BELOVED NEGRO NARRATOR, UNCLE REMUS. HE DIED IN ATLANTA, GA., JULY 3, 1908.
