## Jamaican Judicial Stamps – a plate scratch

From 1898 to 1913, postage stamps overprinted JUDICIAL were used to pay court fees. In 1913, a new design was issued (Nyasaland types printed typo by De La Rue). This design, with new vignette plates, continued to be used with the portraits of King George VI and Queen Elizabeth II. These KG VI and QE II designs were used only for Judicial stamps, but continued to be overprinted.



Watermark Multiple St Edwards Crown, perf 14. These stamps were printed in 10 x 6 panes of stamps, with two panes per sheet. At position 5/2, damage to the vignette plate is visible in the form of a scratch. There is also damage to the beading at the perimeter of the vignette (at around 11 o'clock). Identical marks are seen on both the 6d and 1s values.
