Quitrent Receipt

A Quitrent is paid by a freeholder in lieu of a service. In Rhodesia it was levied on farms granted to early settlers and members of the expeditionary force to Matabeleland, as well as land bought from the British South Africa Company. The annual fee and duty on Quitrent receipts both varied with the size of the farm and the type of grant or purchase. The maximum duty on receipts was 7/6, paid with a stamp, which was levied on farms of over 500 morgens (10,500 acres), which most land grants were.

NOTE.—The Consideration-money set forth in a Transfer may differ from that which appears in the Deed, owing to Sub-sales by the original Buyer.
